## GUALA CLOSURES S.P.A. ANNOUNCES THE UPSIZING AND PRICING OF ITS 500 million 3.25% SENIOR SECURED NOTES DUE 2028 TO REFINANCE CERTAIN OF ITS EXISTING DEBT

Alessandria, Italy, June 23, 2021 — Guala Closures S.p.A. (the "Company") announces today that it has successfully priced an offering of €500 million in aggregate principal amount of Senior Secured Notes due 2028 (the "Notes"), which will be issued at an issue price of 100% and will bear an interest rate of 3.25% per annum (the "Offering"). The Offering is expected to close on July 7, 2021, and is subject to customary closing conditions. The Offering was upsized from the previously announced €475 million aggregate principal amount in light of investors' demand.

Following the issuance, the Notes are expected to be listed on one or more multilateral trading facilities in the European Union.

In connection with the Offering, the Company also announces that it has entered into a new €80 million multicurrency revolving credit facility agreement (the "**New RCF**") to replace the existing revolving credit facility (the "**Existing Revolving Credit Facility**"), which will be available to support, among others, the working capital requirements of the group (together with the Offering, the "**Refinancing**").

The proceeds from the Offering are expected to be used to redeem the Company's €455 million in aggregate principal amount of Senior Secured Notes due 2024 (the "Existing Notes") at a price equal to 100% of the aggregate principal amount thereof, to repay amounts outstanding under the Existing Revolving Credit Facility, to pay accrued interest on the Existing Notes and the Existing Revolving Credit Facility, and to pay fees and expenses associated with the Refinancing. This follows the occurrence of the "change of control" pursuant to the indenture governing the Existing Notes in connection with the mandatory tender offer launched by Special Packaging Solutions Investments S.à r.l.
